# **OAK GROVE RACING, GAMING & HOTEL**

*(Referred to as "The Racetrack" for purpose of these rules)*

*The Racing Handbook, which includes Rules of Racing, Barn and Paddock Rules, etc., are in effect at the time any race is raced, including all non-race days that are associated with the Oak Grove race meet. These rules shall govern the race, and all entries are accepted only with the understanding and on the agreement of the applicant that the Racing Handbook shall govern operations during the Oak Grove meet and shall be included as part of all conditions of the Oak Grove Racing/Stall Application.*

*The Racetrack reserves the right under the racetrack owners "right of exclusion" at any time to deny admission to any part or parts of the properties to an applicant or participant, or any agent acting on his/her behalf.*

*The Racetrack reserves the right under the racetrack owners "right of exclusion" to deny entry into any race, overnight or paid-in event. This includes races upon which payment has been made at any time up to and including time of declaration for that race with no promise of refund of those payments.*

*The Racetrack reserves the right to cancel any race, including both overnight and paid-in events, if the number of nomination/declarations does not meet a minimum requirement set by the track, race secretary, or race sponsor, up to and including time of declaration for that race.*

*The Racetrack reserves the right to a lifetime exclusion from the properties for any person found to be falsely representing themselves to be the trainer of any horse(s) AKA "Bearding".*

*Those rights listed above apply to all participants, patrons, employees, and/or any persons and/or horses under their control. Nothing in these rules and regulations shall in any way limit other rights, which the Racetrack may have.*

*It is a privilege to participate at the Racetrack. Any conduct determined by management, in its sole and absolute discretion, to have an adverse effect on the sport of horse racing or not to be in the best interests of the sport of horse racing, may result in the imposition of a penalty in accordance with these Rules and Regulations.*

*Any horse nominated to any stakes/event as well as the Nominator shall be bound by all Articles in the Conditions for that stake/event.*

*The Racetrack, at its sole discretion as to what it determines to be in the best interest of the races, reserves the right to refuse the participation of any entry or proposed entry. Any horse owned or trained by an owner or trainer who is arrested, indicted or is the subject of a filed governmental criminal information charging such person with administering, selling, sponsoring, or encouraging the sale or use of illegal medications or the illegal or unethical treatment of animals will be ineligible to race in any of the races owned or serviced by the Racetrack. Such ineligibility shall commence on the date of such arrest, indictment or information and continue for a minimum of 60 days from the time of the transfer of ownership of the horse and/or the change of trainers to a bona fide separate and unrelated licensed owner or trainer.*

*Any/all health-related policies as required by the Commonwealth of Kentucky and/or the Racetrack must be followed explicitly.*

*These Rules of Racing, Paddock and Barn Rules shall always apply to the Racetrack's premises, including both the frontside & backstretch area, and to all individuals using these areas, without limitation, either as applicants, residents, party(s) to a contract with the Racetrack, or in any other capacity whatsoever. The Racetrack reserve the right to alter or amend these rules and regulations without notice, at any time as deemed necessary.*

## **Breach of the Rules:**

*A breach of any of the rules and regulations or policies of the Racetrack may result in a loss of privileges, loss of any or all fees and/or eviction from the premises. Any person having knowledge that a breach of any of the rules and regulations or policies of the Racetrack has been committed must immediately report such breach to a security officer, stable area superintendent, track superintendent, staff sergeant or any other employee.*

*Failure to comply with these conditions may result in any agreement created by the acceptance of any stakes payment to be declared void at the discretion of The Racetrack rendering the horse(s) in question ineligible to race in those stakes/events with no liability to The Racetrack and no assurance of a refund of payments previously made to the stake/event in question.*

*It is the goal of the Racetrack to provide a level playing field for all participants and a race product that is beyond reproach.*

## REGULATORY:

1. A Racing Application must be completed and signed or entries may not be accepted at the Racetrack. All conditions within that application apply in concert with these Rules.
2. Upon accepting the right to participate at the Racetrack each trainer agrees to accept full responsibility for the care and welfare of the horses in his/her custody.
3. Each trainer also agrees not to act as a program trainer for or otherwise train or enter any horse in a race for or act in the capacity of any other trainer or owner who is not properly licensed and approved to participate at the Racetrack.
4. All personnel must be licensed by the Kentucky Horse Racing and Gaming Corporation. Each trainer agrees not to employ an individual who is not properly licensed or is under suspension in any jurisdiction under any circumstance.
5. Trainers are responsible for providing Worker's Compensation insurance in accordance with the laws of the Commonwealth of Kentucky.
6. All personnel will be subject to applicable law and all rules and security policies in place while stabled at the Racetrack and/or competing in the Racetrack's events.
7. All horses entering and leaving the stable area must be properly checked at the stable gate with the required paperwork submitted and in order.
8. Persons entering the stable area must possess proper credentials to be admitted by the security representative at the stable gate. Identification must be produced if requested.
9. If required by KHRGC rules, a photo ID badge must be worn and visible while in the stable area and paddock.
10. Guest passes may be available. Contact Racing Office or KHRGC for details. Any guest must always remain in the company of the licensed individual signing for the guest pass.
11. All personnel entering and leaving the stable area of the Racetrack are subject to search and seizure, extending to their person, horses, and vehicle.
12. All persons using the facilities will abide by the lawful direction of racetrack security personnel.
13. The main track hours will be posted throughout the barn area. Use Main Track Gate.
14. The Racetrack prohibits possession of any veterinary medication and/or apparatus to introduce such by anyone other than a licensed veterinarian or vet assistant.
15. Trainers and owners are required to comply with pre-race and post-race blood gas testing procedures and out-of-competition hair sample testing and/or all forms of blood testing.
16. Any horse declared to race may be tested for any medication or prohibited substance at the discretion of the Racetrack and/or the KHRGC administrators at any time. If the tests are conducted by the racetrack and the sample tests positive for a banned substance, the trainer and/or owner will be held liable for the cost of the testing procedure.
17. Any trainer whose horse tests positive for an ARCI Class 1 or 2 drug at the Racetrack may be excluded immediately.
18. Any horse testing positive may be excluded from participating at the Racetrack for a period to be determined by the Racetrack.
19. Any horse that tests positive for any prohibited drug may be required to stable on the grounds and race out of detention as a condition of continued right to participate.
20. Any and/or all races and/or horses may be subject to 24-hour detention at the discretion of the Racetrack.
21. At the discretion of The Racetrack, any trainer or owner may be required to stable their horses on the grounds as a condition to participate.
22. Horses stabled at The Racetrack may not be removed from the grounds on the day they are entered to race.

## **RACING:**

1. Those horses racing at the Racetrack must meet the qualifying standards as listed on the condition sheet for overnight races and meet the qualifying standards as listed in the conditions for stakes races.
2. All horses declared to race must have a racing application on file, Electronic Eligibility, a negative Coggins Test within the required time frame, and any other documents and/or certificates required by State rules or the Racetrack.
3. All horses are subject to individual review and acceptance by the Racetrack, which retains sole discretion to approve or deny any horse.
4. The Racetrack reserve the right to cancel any Race, upon repayment of fees as stated in the stakes conditions, if any; and/or change the time and/or place of any Race.
5. The Racetrack reserve the right to carry any event over one race day with the permission of the Presiding Judge.
6. If any unforeseeable event prevents the racing of any or all added money events, paid in monies shall be refunded as stated in the conditions of the race. All fees and purses are in US Funds.
7. Race distance and field size shall be determined by the Director of Racing as he/she sees fit for any/all events.
8. Any change of trainers made fewer than 30 days or within four starts of the date of a stakes race will be reviewed by the sponsor. If such change is not accepted, it may result in refusal of entry.
9. The Racetrack reserve the right to deny stall space, reject any entry, change the program order, place improperly declared horses in correct classes and declare off any race that does not fill.
10. No medication is permitted in the paddock.
11. The Racetrack reserve the right to require drivers to apply for approval to race in stakes or overnight races.
12. Drivers agree to adhere to the Rules & Policies provided to them as necessary by The Racetrack and/or Presiding Judge.
13. Drivers are required to wear colors with clean white pants or a professional training suit along with driving boots & pant clips in qualifying races. Colors, clean white pants and driving boots with pant clips are required for warming up horses for the race cards.
14. Helmets must be worn with the chin strap buckled while on the racetrack at anytime.
15. Drivers must wear a safety vest along with helmet and colors when driving in a race.

## **STABLING/BARN AREA:**

1. Horses shall always have the right of way in the stable area.
2. Any person operating a motorized vehicle must have a state issued operator's license.
3. Any motorized vehicle in the stable area must have state registration as required by law.
4. Motorcycles are not permitted in the stable area.
5. Posted speed limits must be observed.
6. All vehicles must be parked in designated areas.
7. Horse trailers must be parked where indicated.
8. Horse manure must be deposited in the bins provided and the area kept clean.
9. Garbage is to be placed in proper receptacle and is not to be thrown into manure bins.
10. Under no circumstances is refuse from off the grounds to be dumped at the racetrack.
11. The use of portable paddocks, pens or corrals in the stable area is prohibited.
12. Trainers are responsible to ensure that Fire Prevention rules are followed.
13. Smoking in any area of the Racetrack may be prohibited.
14. All appliances for heating and cooking are prohibited.
15. Combustible liquids must be stored outside the barns in approved containers.
16. Firearms are prohibited.
17. Any electrical device must be plugged directly into an outlet and have UL approval tags visibly attached to the appliance or cord. Extension cords must be UL approved and may not be left unattended.
18. Electrical panels and/or power sources and fire extinguishers must be made readily available to access. Doors to tack rooms where these devices are installed must remain unlocked and a 36-inch clear area around these devices must be maintained.
19. Alcohol consumption and the possession and/or use of controlled substances within the stable area are prohibited. Exceptions may be made for those with a prescription.
20. No dogs may be permitted in the stables without express permission.
21. Living in the barns is prohibited. Tack rooms are to be used for equipment storing only.
22. Trainers are responsible for informing the security office of any change in their staff.
23. The Racetrack is not liable and assumes no responsibility for loss by fire, theft, or accident of or to persons, animals, equipment, or vehicles owned, leased, or controlled by any or all of the foregoing. Use of the grounds, track or facilities owned by the Racetrack is at the risk of the party or parties responsible for entries and is assumed by those individuals.
24. Applicant agrees to vacate stall and move all horses, equipment, and personnel off the premises within 48 hours of notice to do so.

***Any Violation of These Rules of Racing and Paddock and Barn Rules May Result in the Scratch of Any Horse in Question, Fines, Suspension and/or Expulsion. Any Action Taken to Implement or Enforce These Track Rules, Or in Furtherance Thereof, Shall Be Without Any Liability to The Racetrack and/or its Employees.***

REQUIRED DOCUMENTATION

- Negative Coggins test (1 year)
- Health certificate (10 days for in-state, 72 hours for out-of-state), and proof of EHV vaccinations (6 months) must be presented at the stable gate. Entry will be denied if not provided at the time of arrival
- NO PHONE PICTURES WILL BE ACCEPTED

- Horses shipped to Oak Grove without **approval** will not be unloaded.
- If Allotted stalls, there shall be no substitution of horses without the consent of the racing secretary and a stable roster must be submitted
- Stall Rental will be charged monthly
- Each stall must be stripped when vacating, failure to comply will incur a \$50 per stall fee and will result in future stall denial

**CONDITIONS TO STABLING, ENTRY IN RACES,  
RELEASE, AND INDEMNIFICATION AGREEMENT**

By executing this application for the revocable grant of stall space by WKY Development, LLC dba Oak Grove Racing, Gaming & Hotel ("Oak Grove") and/or accepting a grant of stall space, the undersigned ("Trainer") agrees on behalf of himself, and each of the Owner(s) listed on the reverse side hereof, as follows:

1. **Rules and Regulations.** Trainer agrees that, in connection with and as a condition to Trainer's application for and/or acceptance of stall space at Oak Grove's Racetrack ("Oak Grove Facilities"), the shipping in of any horse to Oak Grove Facilities and/or entry of any horse in a race run at Oak Grove's racetrack, Trainer will comply with and abide by all terms, provisions and conditions set forth in this Agreement, all administrative regulations of the Kentucky Horse Racing and Gaming Corporation ("KHRGC") and all rules, conditions and regulations of Oak Grove, at any time adopted or as they may be amended. Trainer shall be responsible for obtaining and becoming familiar with such rules and regulations. Oak Grove reserves the right to make all decisions regarding preferences, conditions and the interpretation and application of any rules and regulations and its decision as to same shall be final and Trainer agrees to comply with and abide by any decisions of the state racing officials and/or the officers of Oak Grove with regard to same.
2. **Investigation of Trainer.** In connection with this Application, Trainer agrees and consents to Oak Grove and/or its agents making an investigation of Trainer, whereby information may be requested from third parties as to character, general reputation as may be relevant to Trainer's integrity as a racing participant.
3. **Reservation of Rights.** As the organizer, host and sponsor of Standardbred horse races, Oak Grove hereby reserves unto itself, its agents, assigns and licensees and Trainer hereby assigns to Oak Grove all interest it may have in the Host Rights as herein defined. The Host Rights shall mean the sole and exclusive right to: (a) produce, exhibit, sell, license, transfer or transmit in any manner still or motion pictures, radio and television broadcasts, interactive computer including internet or any other media transmission, now known or hereafter developed, of all events which occur on Oak Grove's property, including without limiting, all activities occurring before, during and after horse races; b) utilize the Race and the results thereof, all for any purpose or use as Oak Grove shall determine; (c) limit, prohibit or regulate the display of any commercial advertising symbols, or other identification, other than Trainer's registered silks, in connection with any Race or related activities; and develop, produce and sell, by or through any licensee, goods using the Trainer's name or likeness, the name or likeness of any horse owned by the Trainer brought onto Oak Grove's grounds, or any other identifying feature, silks, trademark or copyrighted material which is used in connection with the Races. The submission of a nomination or making of an entry in any Race shall mean that the Trainer consents to the above reservation of the Host Rights and consents to be photographed or to otherwise be a subject of still or moving pictures, electronic, radio or television programs, without remuneration except for contributions to horsemen's purses from wagering on the Races as established by contract or legislation. The Trainer agrees that he has not and shall not execute any documents or take any other action which purports to assign or otherwise transfer any interest in the Host Rights or assert any claim, demand or cause of action against Oak Grove which is inconsistent with the full and exclusive exercise by Oak Grove of its Host Rights.
4. **License.** Allocations of all stall space are made only with the agreement of Trainer that Oak Grove reserves to itself the exclusive right, in its sole discretion, to enter, modify, alter or change to physical condition or use of any of its facilities; that the permission granted herein to Trainer to use Oak Grove's facilities is solely for purposes incidental to racing, does not constitute a lease of such facilities and Oak Grove maintains the sole interest in and exclusive control of its premises and facilities; and that Oak Grove reserves to itself the exclusive right and sole discretion to reduce or to totally eliminate the number of stalls assigned and/or change the location of stalls assigned to the Trainer.
5. **Revocation.** Trainer agrees that the license granted herein to enter on the Oak Grove grounds and to use the Oak Grove facilities is subject to revocation, with or without cause, and in the sole and exclusive discretion of Oak Grove, upon 48 hours' notice in writing delivered by mail, telegraph or in person to Trainer or to Trainer's address indicated on the reverse side or such other address as may be indicated by Trainer in the future. A violation of the rules or regulations of the KHRGC or the conditions, rules and regulations of Oak Grove or the creation, in whole or in part, by Trainer of any condition that may interfere with the safe and efficient operation of its business by Oak Grove or the termination of the Trainer's agency relationship with the Owner(s) listed on the reverse side hereof, shall, in each case, subject this license to immediate revocation exercised at Oak Grove's sole and exclusive discretion, without any prior notice.
6. **Release and Indemnification.**
  - A. All Kentucky Horse Racing and Gaming Corporation licensees, including but not limited to Oak Grove, owners, trainers, jockeys, and grooms ("licensees"), participating in stabling, racing, training, and related activities at Oak Grove recognize that hazards and risks inherent in such activities may cause the injury or death of horses. Therefore, in consideration of participating in stabling, racing, training, and related activities at Oak Grove, all licensees assume the risks of, and release, hold harmless and covenant not to sue all other licensees so participating for: (i) Ordinary negligence which causes or contributes to loss, loss of use, injury or damage to horses while on the premises of Oak Grove; and (ii) Ordinary negligence which causes or contributes to personal injury or property damage, including but not limited to loss, loss of use, injury or damage to horses arising from the use of grass fields or gallops owned or controlled by Oak Grove, whether arising from alleged acts or omissions of a licensee and its agents or employees, the condition of the premises of Oak Grove or any other cause. Except as provided above, all licensees participating in racing, training, and related activities at Oak Grove shall be responsible for their own acts and omissions and those of their agents and employees to the same extent as provided by law.
  - B. The foregoing provisions shall be construed in a manner consistent with the limitations set forth herein to be as broad and inclusive as permitted by the laws of the Commonwealth of Kentucky and the KHRGC's regulations and shall be binding upon Trainer, its successors and/or assignees. The maintenance by Oak Grove of insurance shall not affect the terms or interpretation of this Agreement. For purposes of this Agreement, Oak Grove shall mean and include Oak Grove and its officers, directors, agents, employees, contractors, servants and licensees. In the event of any inconsistency between these provisions and the KHRGC's regulations, the KHRGC's regulations shall control. Further, these provisions shall be deemed to be amended to the extent of, and to follow, any amendment to the KHRGC's regulations. Trainer shall, prior to its admission to Oak Grove's facilities, deliver to Oak Grove, certificate evidencing the maintenance of Worker's Compensation Insurance for all employed personnel in accordance with the statutory requirements of the Commonwealth of Kentucky. Responsibility for the maintenance of general liability and horse mortality insurance to cover the risks outlined above vests with the Trainer and/or Owner, as the case may be. Consultation with a competent insurance advisor is strongly recommended. Failure to maintain adequate insurance may subject Trainer or Owner to the risks outlined above. OAK GROVE SHALL HAVE NO OBLIGATION WITH RESPECT TO SUCH INSURANCE. Failure to maintain adequate insurance may subject Trainer and/or Owner(s) to multiple and substantial risks, including being excluded from Oak Grove's premises. Owner(s) and Trainer indemnify and hold Oak Grove harmless against any claims, liabilities, judgments, or costs (including attorney fees) arising out of the Trainer and/or Owner(s) failure to obtain insurance as appropriate and as may be required by law.
7. **Cancellation of Races.** Oak Grove reserves the right to cancel any race, without notice, at any time prior to the actual running thereof, without liability, except for the return of fees as required by the administrative regulations of the KHRGC. Nominations or the making of any entry to any of the Races is received with the understanding that Oak Grove reserves the right to refuse, cancel or revoke any nomination or entry or the transfer thereof for any reason and without notice.
8. **Stabling and Training Rules.** Training on the Oak Grove track will be allowed only at such times, if any, and only in accordance with any instructions and directions regarding training activities as may be determined by Oak Grove. Applications for stall allocations are received only with the understanding that Oak Grove reserves the right to refuse, cancel or revoke any stall application or the transfer thereof for any reason and without notice to Trainer.
9. **Revision.** The intent and language hereof may be subject to revision during the term of any applicable horsemen's contract based upon any judicial decision or legislative action.
10. **Miscellaneous.** This Agreement shall be effective with regard to Trainer's stabling during and/or participation in the race meeting specified on the opposite side hereof and Trainer's participation in any and all other race meetings and related activities. For purposes of this Agreement whenever the word "Trainer" is used herein, it shall include the Trainer (and if Trainer is an agent/assistant to any Trainer, the principal for whom he is agent), all Owner(s) or horses controlled by Trainer, and their heirs, representatives, successors, next of kin and assigns; provided, however that the rights and benefits of the Trainer under this Agreement are personal and no such right or benefit shall be subject to voluntary or involuntary alienation, assignment or transfer. Trainer covenants that the Owner(s) have agreed to the foregoing conditions and further agrees that he will deliver their written consent and agreement to such conditions upon request of Oak Grove. Trainers shall indemnify and hold Oak Grove harmless from and against any claim or cause of action (including any expense incurred in connection therewith, including reasonable attorneys' and other fees) that may be asserted by or on behalf of any person which is inconsistent with the release and indemnification provisions set forth in the foregoing paragraphs. This Agreement shall be governed by, interpreted and enforced in accordance with the laws of the Commonwealth of Kentucky.
11. **Veterinary Examinations.** In the event that Oak Grove's in-house veterinarian (the "Oak Grove Veterinarian") or any Oak Grove racing official or other racing personnel have reason to believe, based on their observations or information provided or available to them, that a horse stabled on Oak Grove's property by Trainer is injured, unsound, in distress, or otherwise unfit to train or race, then Oak Grove may request that Trainer make such horse available for examination by the Oak Grove Veterinarian or, alternatively, at the request of the Trainer, by a licensed Kentucky Horse Racing Commission Veterinarian ("Commission Veterinarian"). If Trainer refuses to have the horse examined by either such veterinarian, then Oak Grove may refuse to permit the horse to train and/or race on Oak Grove's property until the horse is cleared for training and/or racing by the Oak Grove Veterinarian or a Commission Veterinarian. In the event that the horse is examined by the Oak Grove Veterinarian or the Commission Veterinarian and deemed injured, unsound, in distress, or otherwise unfit to train or race, then Oak Grove may refuse to permit the horse to train and/or race on Oak Grove's property until the horse is subsequently cleared for training and/or racing by the Oak Grove Veterinarian or a Commission Veterinarian, as applicable.

Pursuant to 810 KAR 8:040, the Kentucky Horse Racing and Gaming Corporation (the "KHRGC") is authorized to conduct "out of competition" testing on any horse that is eligible, or that may become eligible, to race in Kentucky. A horse is eligible to race in Kentucky if it is under the care, custody or control of a trainer licensed by the KHRGC; or is owned by an owner licensed by the KHRGC; or is nominated to a race at an association licensed by the KHRGC; or has raced at an association licensed by the KHRGC within the previous twelve calendar months; or is stabled on the grounds of an association or training center subject to the jurisdiction of the KHRGC; or is nominated to participate in the Kentucky Standardbred Development Fund. The KHRGC is authorized to test for blood doping agents, venoms and their derivatives, and growth hormones. The regulation also prohibits possession of the foregoing substances, as well as whole blood or packed red blood cells, on the grounds of an association or training facility subject to the jurisdiction of the KHRGC. A horse designated for testing must be made available for sampling at a mutually agreed-upon location within six hours of notification that it has been designated for testing. If a horse is not made available for testing, or if there is any other failure to cooperate with the KHRGC, the individual(s) responsible will be penalized to the full extent allowed by the regulation. If a horse tests positive for a prohibited substance, the owner and trainer are notified of the test results, and the horse is placed on the Veterinarian's List pending a steward's hearing. The owner and/or trainer have the right to split sample analysis, as set forth in Title 810 of the Kentucky Administrative Regulations. If the positive finding is confirmed, serious penalties shall be imposed, including but not limited to, the revocation of the violator's license for a period of five to ten years. - **NO KIDS** UNDER THE AGE OF 16 IN THE PADDOCK
- Respect Oak Grove Team Members and other horsemen
- Everyone entering the paddock must have a current and visible KHRC License, unless dressed in driving colors
- No Smoking Indoors
- No Alcohol
- No fighting or cussing
- Clean up around your stall
- Tools borrowed must be returned
- Do not throw saddle pads on the ground
- Agitated or destructive horses must have a handler present at their stall at all times
- All persons in the paddock must adhere to paddock judge's requests

*We reserve the right to refuse service to any individual or entity for any reason, including but not limited to disruptive behavior, violation of established policies, or any other actions deemed inappropriate by Oak Grove. - Barn Curfew 10pm, unless you are tending to a horse emergency.
- When Leaving, All Stalls Must Be Stripped. Stalls not stripped will be charged a fee of \$50 per stall and you will not get stalls in the future.
- Remove all Nails, screws and staples inside of the Stalls
- Any Damage to stall or the facilities must be reported to the race office immediately
- Horse Trailers are not allowed in the Barn
- Perimeter Fencing must be shut at all times

Penalty for Not Following the Rules Listed above will result in Suspension from the Property and Stall Rent Will be forfeited.
